CHAMPIONING ECD REFORMS: PS AGENG'O AT THE 6TH NATIONAL STAKEHOLDERS' CONFERENCE

From 15th to 17th July, 2025, Garissa County hosted the 6th National Early Childhood Development (ECD) Stakeholders' Conference under the theme "Promoting Transformative Systemic Change in a Child's Ecosystem." The forum also marked the 10th anniversary of the ECD Network for Kenya (ECDNeK) and brought together stakeholders from government, civil society, development partners, academia, and county leadership.

Principal Secretary CPA Carren Ageng'o, who led the State Department for Children Services delegation, emphasized the importance of embedding protection, care, nutrition, and learning into development plans. "Strengthening childcare is not just about services—it's about creating ecosystems where children thrive," she said during her keynote.

Advancing Equity and Coordination

The conference focused on practical reforms to tackle long-standing barriers to ECD service delivery, such as limited financing, fragmented systems, and the exclusion of children with disabilities. PS Ageng'o highlighted government efforts like the Positive Parenting Programme, the NICHE initiative, and the upcoming Kenya Integrated ECD Policy 2024.

Latest national data shared during the forum revealed that nearly 1 in 2 children in Kenya face violence before age 18, and over a third of 3–5-year-olds are not enrolled in early learning programs. Participants discussed how stronger

data systems like CPIMS, multi-sector collaboration, and inclusive governance can help close these gaps.

A Decade of Progress and a Call to Action

The event celebrated 10 years of ECDNeK's work in advocacy, research, and innovation. Leaders including Prof. Teresa Mwoma and Mr. Oscar Kadenge encouraged stakeholders to continue building bold, community-led, and data-driven solutions.

In his opening remarks, Garissa Governor H.E. Nathif Jama Adam pledged continued county-level support for child development, despite regional challenges. The conference concluded with a united call to align systems and partnerships for an equitable future—where every child is protected, empowered, and given a fair start in life.

SUPPORTING EVERY CHILD: HIGH-LEVEL VISIT TO KABARNET SCHOOL FOR THE DEAF AND BLIND

On 18th July 2025, the Cabinet Secretary for Gender, Culture and Children Services, Hon. Hannah Wendot Cheptumo, led a high-level delegation on an official visit to Kabarnet School for the Deaf and Blind in Baringo County. She was accompanied by Ms. Anne Wang'ombe, Principal Secretary for Gender Affairs and Affirmative Action, and CPA Carren Ageng'o, Principal Secretary for Children Services.

The visit commenced with courtesy calls to the County Commissioner and H.E. Governor Benjamin Cheboi, EBS, EGH. The delegation engaged in discussions focused on strengthening collaboration between national and county governments in advancing child protection, gender equality, and disability inclusion.

As part of the mission, the delegation officially handed over donations to Sunrise Children's Home and other schools across the county. Contributions were made by the Child Welfare Society of Kenya, National Council for Children Services, Kenya Red Cross Society, State Department of Special Programs, and the Gender Violence Recovery Centre. These items are expected to enhance the care and support provided to vulnerable children in the region.

During community engagement sessions with

children, caregivers, parents, and local leaders, the delegation emphasized the importance of providing equal care, love, and opportunity to all children, particularly those living with disabilities. The forum also served as a platform to sensitize the community on ongoing government programs supporting orphans and vulnerable children.

Raising concern over rising cases of child neglect in the county, PS Ageng'o urged parents and guardians to embrace their roles more intentionally, ensuring that all children grow up in safe, nurturing, and inclusive environments.

The visit reflected the Ministry's growing commitment to coordinated and multisectoral support for vulnerable children and families, with a particular focus on joint national-county action.

STRENGTHENING SOCIAL SAFETY NETS: PS AGENG'O HOSTS FCDO DELEGATION FOR STRATEGIC DIALOGUE

On 10th July 2025, the Principal Secretary for the State Department for Children Services, CPA Carren Ageng'o, hosted Ms. Eduarda Gray, Deputy Director of the Foreign, Commonwealth and Development Office (FCDO), and her delegation from the British High Commission for a high-level courtesy call.

The meeting reaffirmed the strong bilateral relationship and mutual commitment between the Government of Kenya and the United Kingdom to enhance social protection programs targeting vulnerable populations. In particular, both parties emphasized the urgent need to scale up collaborative efforts in maternal and child health and nutrition, as key pillars of a resilient social safety net.

Discussions also explored the value of strengthening integrated, community-based approaches that draw on the combined strengths of government agencies, development partners, and local systems. The Principal Secretary reiterated the State Department's commitment to multisectoral collaboration, data-driven decision-making, and innovative service delivery models that protect children and uplift families. Both sides agreed to continue advancing joint programs that deliver meaningful outcomes for children across Kenya.

ADVANCING SAFE MIGRATION: PS AGENG'O HOSTS IOM-UN FOR STRATEGIC ENGAGEMENT

The Principal Secretary, State Department for Children Services, CPA Carren Ageng'o, on 10th July 2025, hosted a delegation from the International Organization for Migration (IOM UN), led by the Acting Chief of Mission, Mr John McCue. This high-level engagement strengthening focused on strategic cooperation in the prevention of human trafficking and enhancing support mechanisms for vulnerable migrant children.

IOM-UN continues to work alongside the Government of Kenya by providing technical expertise, building institutional capacity, and supporting the implementation of programmes that promote safe, orderly, and dignified migration.

The discussions underscored the critical importance of both bilateral and multilateral collaboration in eliminating human trafficking, particularly among at-risk children. The State Department reaffirmed its commitment to cross-sectoral partnerships aimed at protecting children on the move and upholding their rights across borders.

The event further underscored the importance of county and national government collaboration in scaling up access to quality, inclusive, and child-friendly early learning infrastructure.

The classrooms represent a major milestone in the county's ECD agenda and are aligned with the national theme of the conference: "Promoting Transformative Systemic Change in a Child's Ecosystem." They serve not only as learning spaces, but also as symbols of progress toward a nurturing, equitable, and well-resourced future for Kenya's youngest learners.



IF YOU SEE SOMETHING, SAY SOMETHING: KANGUNDO'S BOLD STEP FOR CLEAN JUSTICE

SUCCESSFUL REINTEGRATION OF A CHILD FROM HOMA BAY TO MBEERE SOUTH, EMBU COUNTY

On 17th July 2025, a minor was successfully reintegrated to Mbeere South Sub-County, Embu County, from Homa Bay County, following a coordinated child protection response. The child had been misled by a relative with false promises of education but was instead subjected to child labour.

Following a rescue operation, the child was temporarily placed in a Charitable Children's Institution as tracing and reintegration efforts were initiated. Deputy County Commissioner, Mr. Mwaura supported the reintegration process on behalf of the Sub-County Children Officer, who was attending court at the time.

Special appreciation goes to Sub-County Children Officer Madam Beth, whose support, coordination, and groundwork ensured a smooth transition and a soft landing for the child.

This case underscores the value of inter-agency collaboration and the State Department's continued commitment to safeguarding the rights and welfare of every child, regardless of county boundaries.
